The Workforce Innovation and Opportunity Act is designed to help youth, 14-24 years old, overcome barriers regarding education and employment. This program has a focus on out of school youth and funds are available for both state and local organizations. WIOA Youth Program works to provide skills and credentials for youth to secure employment.

The Reentry Employment Opportunities (REO) Program is for justice involved youth, young adults, and adults. The REP program works with state and local organizations to improve outcomes for currently or formerly incarcerated individuals.

Young Adult Reentry Partnership (YARP)- YARP helps reentry organizations create partnerships with local community colleges. YARP focuses on serving the 18-24 year old population. The program supports this age group by helping them obtain industry recognized credentials, certificates, and develop job readiness skills.

Reentry Projects- Reentry Projects supports 18-24 years old during their reentry process. These programs aim to increase employment outcomes and do so through the use of grants and evidence based practices. Organizations can apply for these grants and create a new program based on promising interventions.

Pathway Home - The pathway home project serves both young adults and older adults. The Pathway home grants work to provide employment between release and enrollment in a reentry program. Programing starts prerelease and is designed to help local and state stakeholders with the reentry process.

Federal Bonding Program- Federal Bonding Demonstration Grants allow states to use their fidelity bonds to assist formerly incarcerated individuals and those suffering from addiction with employment opportunities.
